THROUGHOUT 2024, MDC SERVED 2,172 MEN, PROVIDING 96,435 NIGHTS OF LODGING AND 215,399 MEALS. IN ADDITION, THE WORKFORCE DEVELOPMENT TEAM ASSISTED 78 MEN IN FINDING EMPLOYMENT IN 2024.
